



CNA presents the second part of inconsistencies identified in Banasupro Bonosupro: a social fraud

CNA presented the second part of the inconsistencies identified in Banasupro, through the report called: "Bonosupro's solidarity illusion", a program in which bonds were delivered knowing that they could not be exchanged. It was

found that the number of coupons distributed nationwide was 181,279; Of these, 141,279 could not be exchanged, and of the 40,000 coupons that could be exchanged, only 10,808 were duly and legally paid to people from only seven of

the country's eighteen departments. The failed management of these deliveries suggests mismanagement by both parties involved, with a remaining 170,471 unpaid coupons and without monetary support, playing people's hunger.

THE NATIONAL CONGRESS APPROVED A "SPECIAL LAW ON THE ORGANIZATION AND OPERATION OF THE NOMINATING BOARD FOR THE PROPOSAL OF CANDIDATES FOR MAGISTRATES OF THE SUPREME COURT OF JUSTICE."

The National Congress at 11:55 p.m. approved the Special Law of Organization and Functioning of the Nominating Board for the Proposition of Candidates for Magistrates of the Supreme Court of Justice (CSJ), which was voted in favor by 73 of the 127 deputies present at the legislative session, while 44 voted against, 10 did not vote, and no congressman

abstained. On the other hand, on April 26 of the current year, the CNA launched a campaign called: "Transparent elections of magistrates and prosecutors", #QueNoPaseDeNuevo, #ElecciónSinDisfraz, with the aim of demanding a stop to judicial corruption.

THE SENTENCE FOR MARCO BOGRÁN AND ALEX MORAES IN THE MOBILE HOSPITALS CASE WAS DENOUNCED BY THE CNA ON AUGUST 3RD, 2020.

The former director of Invest-H, Marco Bográn, was sentenced to 10 years with 11 months in prison, plus payment of more than L.1,475 million for the purchase of the seven mobile hospitals that the State acquired through a Turkish company to face the COVID-19 pandemic.

On the other hand, Alex Moraes received a sentence of nine years, four months, and fifteen days of special disqualification from holding public office, he was also charged with the

purchase of said hospitals.

It is important to remember that the CNA denounced this fact on August 3, 2020, the same civil body that presented a total of fourteen reports on: "Corruption in times of COVID-19", where different irregularities were exposed in a timely manner that demonstrate the inefficiency of public institutions to provide the necessary supplies and equipment to patients who were infected with COVID-19.

Publication of the report: Investment Climate Statement 2022: Honduras



The US Department of State presented a report on Investment Climate, in which Honduras was identified as a risk for foreign investment, reflecting a clear interference in the actions of the Honduran government on issues of national relevance, as investors point to corruption, crime, poor infrastructure, and weak or non-existent rule of law as the main reasons why Honduras does not attract more investment.

The Engel list was published and some Honduran officials shake like a leaf



On July 20th, the United States-Northern Triangle Enhanced Engagement Act, better known as the Engel list, was published.

According to the new list, there are 15 sanctioned Honduran citizens, which includes members close to the Xiomara Castro government: two deputies from Libertad y Refundación and vice presidents of the National Congress: Rasel Tomé and Edgardo Casaña; Mention was also made of the former minister who has been presented as a presidential adviser to the Castro government, Enrique Flores Lanza.

On the other hand, there was a failed attempt to subject two vice presidents of the National Congress to impeachment for appearing on this list, however, the board of directors of the National Congress rejected said request.
